HEALTH GUARANTEE:

Snowstorm Bullies has very strict natural breeding requirements. Thus, our strict breeding program does not only cater to *puppy intelligence* and *size*, but to their quality, soundness, and their health as well. This is accomplished by requiring a medical clearance from a state licensed veterinarian. Snowstorm Bullies will guarantee that the stud will be current on all vaccinations and free from the following: DISTEMPER, ADENOVIRUS, PARAINFLUENZA, PAVOVIRUS, LEPTOSPIRA, CORONAVIRUS, BRUCELLA as well as any life threatening genetic defects. Snowstorm Bullies will certify that the stud's diet, shots, worming, bathing, and any other treatments will be consistent before and throughout the breeding process. The Bitch Owner is encouraged to have the Bitch examined by a state licensed veterinarian within 72 hours of breeding, at their expense. Snowstorm Bullies shall not be held responsible for the development of genetically derived faults, which are due to the Bitch Owner's DNA structure and/or inaccurate or false medical reports surrendered by the Bitch Owner.

TERMS AND CONDITIONS

If it is revealed that the Bitch Owner is fighting or has fought any puppy/adult dog that is a direct descent of the litter studded from Snowstorm Bullies, the Bitch Owner will surrender the puppy/adult dog to Snowstorm Bullies and pay for all costs associated in the safe acquisition of the puppy/adult dog under distress.

CONCEPTION

Snowstorm Bullies is not liable for incorrect testing done to predict ovulation by the Bitch Owner. If the Bitch fails to become pregnant after 30 days, the Bitch Owner must notify Snowstorm Bullies. Two live puppies constitutes a litter. Snowstorm Bullies does not guarantee live puppies upon whelping. It is the responsibility of the Bitch Owner to sustain life of the whelping litter after birth.

If the Bitch does not conceive as a result of the natural breeding process, then the Bitch owner shall notify Snowstorm Bullies and this contract will be voided. The Bitch owner must notify Snowstorm Bullies 1 week prior to the desired breeding date.

PUPPIES

Puppies produced as a result of this breeding cannot be sold to or placed with a "broker" or any retail establishment (ie. pet shop or puppy mills). Furthermore, the Bitch owner agrees that no puppies will be placed in a commercial breeding facility. If assistance is needed to sell or offload puppies, Snowstorm Bullies is willing to assist in the promotion and marketing of the puppies for a reasonable and negotiated commission with the Bitch Owner. The Bitch Owner shall be required to take pictures of the puppies at birth and upon them reaching 6 weeks of age. The Bitch Owner shall forward pictures to Snowstorm Bullies. The whelping kennel shall make reasonable accommodations for Snowstorm Bullies to physical view the litter, if they deem necessary.

Snowstorm Bullies understand that most breeders sell puppies at a "first right to refusal" clause. Snowstorm Bullies will assist the Bitch Owner in finding the puppy a loving home, if requested. Snowstorm Bullies wishes the Bitch Owner to understand that they take the breeding of said stud very serious and will be very interested in the puppies resulting from this litter for their entire lifetime. Snowstorm Bullies may agree to accept returned puppies if the Bitch Owner is unable to at that time.

- ✓ Support this breeding in any manner resulting in good morale and welfare of the whelping puppies and their mother.
- ✓ Be responsible in ensuring that the puppies are safe and healthy while in their care.
- ✓ Treat SnowStorm with respect as a business and as animal lovers.
- ✓ Honor every segment of this agreement, and advise SnowStorm Kennel of any unfortunate and unforeseen occurrence that may unintentionally breech this contract.
