SNOWSTORM HEALTH GUARANTEE:

Snowstorm Bullies has a very strict breeding requirement. Thus, our strict breeding program does not only cater to puppy intelligence and size, but to their quality, soundness, and their health as well. Snowstorm Bullies will guarantee that the puppy at the time of delivery will be current on all vaccinations and free from all genetic health defects. Snowstorm Bullies will certify that the puppy's diet, shots, worming, bathing, and any other treatments will be consistent before and throughout the whelping process. It is strongly recommended that the buyer have the puppy health checked by a state license veterinarian within 72 hours of the said puppy being in the buyer's custody. If any deficiencies are found and veterinarian documentation claims that the puppy's illness was caused while in the care of Snowstorm Bullies; the buyer (at their expense) can seek a second opinion. If the diagnosis of the second opinion verifies an illness while in the care of Snowstorm Bullies; At Snowstorm Bullies' discretion they shall either cover the veterinarian cost to bring the puppy back to optimum health or refund the full purchase price of the puppy will be refunded.

It shall be understood that this contract does not cover viral illnesses, parasites, infections, improper bites, giardia, coccidiosis, or kennel cough. It also does not cover illnesses due to the ingestion of foreign objects, food, chemicals, stress related issues, behavioral issues, physical injuries and/or illnesses which may have occurred and/or contracted after the puppy has been delivered. Snowstorm Bullies promises to make the buyer aware of any and all known health issues before the purchase of said puppy. Snowstorm Bullies is not liable for any accident or injury of the puppy once it leaves Snowstorm Bullies' care. Furthermore, after the puppy leaves our care, Snowstorm Bullies has no control over how the puppy is handled, where the puppy is taken, or what the puppy is exposed to.

TERMS AND CONDITIONS

If it is revealed that any dog purchased from Snowstorm Bullies is caught fighting or has been directly related to any illegal activity, the Buyer will surrender the puppy/adult dog to Snowstorm Bullies and pay for all costs associated in the safe acquisition of the puppy/adult dog under distress.

Puppies produced as a result of this breeding shall not be sold to or placed with a “broker” or any retail establishment (i.e: pet shop or puppy mills). Furthermore, the Buyer agrees that no puppies will be placed in a commercial breeding facility. If the Buyer is not able to care for the puppies due to any unfortunate living conditions, or if the Buyer cannot guarantee the safety and the welfare of the puppy, Snowstorm Bullies may be willing to pay all necessary costs in the shipping and transportation of the puppy/dog to their facility/kennel, if they so desire.

As a courtesy and by request, the Buyer shall consider taking pictures of the puppy/adult dog purchased at Snowstorm Bullies every 6-months until the dog is 3 years of age. The Buyer shall forward pictures to Snowstorm Bullies via email, text, and/or US mail.

Snowstorm Bullies understand that most breeders sell puppies at a “first right to refusal” clause. If Snowstorm Bullies cannot reassume custody of the puppy/dog, then they will assist the Buyer in finding the puppy a loving home. Snowstorm Bullies wishes the Buyer to understand that they take their litters very serious and will be very interested in the puppies resulting, from this litter, for their entire lifespan. Snowstorm Bullies agrees to accept returned puppies but under renegotiated conditions and terms at the time of reacquisition, coupled with the commitment detailed above.

REGISTRATION AND DISCLOSURE

Snowstorm Bullies bares the responsibility of registering each whelping litter within 2 weeks of production. Snowstorm Bullies will surrender puppy registration application (UKC and/or ABKC) to the Buyer immediately upon receiving the entire balance of the listed in this contractual agreement. The Buyer bares the responsibility of registering the said puppy to the appropriate kennel club. The Buyer shall use Snowstorm Bullies as the prefix when exhibiting/registering the said puppies. The registered name of the said puppy will be prefixed with the name "Snowstorm's".

Snowstorm Bullies Agrees to:

- ✓ Strongly adhere to the agreed date, time, location, and special circumstances regarding its shipping and delivery program and the sale of the puppy.
- ✓ Provide the latest vaccination and deworming names and dates that the puppy has received.
- ✓ Sign litter registration application promptly upon payment in full of the said puppy.
- ✓ Treat the Buyer and their kennel with respect as a business and animal lover.
- ✓ Support the Buyer in any other manner requested.
- ✓ Stand behind this contract and if voluntarily/intentionally breached by the Buyer, retaliate in court of law.
- ✓ Honor every segment of this agreement and advise the Buyer of any unfortunate and unforeseen occurrence that may unintentionally breach this contract.

The Buyer Agrees to:

- ✓ Send pictures every 6 months of the puppy purchased until the puppy/dog reaches 3 years of age.
- ✓ When convenient, send weight and measurements of the puppy every 6 months for the first 3 years.
- ✓ Pay the deposit and balance of the cost within the time period specified.
- ✓ Pay all associated deposit fees, shipping costs, ear cropping costs, microchipping costs (if required), and international vaccination costs (if required) at the time the puppy is reserved.
- ✓ Be responsible in ensuring that the puppy/dog is safe and healthy while in their care.
- ✓ Treat Snowstorm Bullies with respect as a business and as animal lovers.
- ✓ Honor every segment of this agreement and advise Snowstorm Bullies of any unfortunate and unforeseen occurrence that may unintentionally breach this contract.
